

Last meeting prior to Food and Fun event.

Meeting called to order at 10am by Al S. President.

Secretary's Report – the minutes were circulated 10 minutes prior to the meeting for review by those in attendance. Al asked if there were any amendments or corrections. Secretary Jenn P asked for clarification on the board positions up for nominations. The June meeting notes indicated that nominations will be taken for Vice President and Secretary during the August meeting. The August 2nd meeting minutes reflect the nominations are for Vice President and Secretary. It was decided that the June notes needed amending as the nominations currently open are Treasurer and Vice President. No adjustment to August meeting notes needed. VP / Equipment Manager Report - Mike P. deferred to Mike S. for the update on equipment, etc. Mike presented an update on current issues with equipment, needs and research completed for acquiring new or used equipment. Differences in types of equipment, costs, new versus used and timing of selling current equipment and securing / receiving new /used equipment. Al S. stated that the financing has been submitted and approved for any financing that the club may need to replace the current large equipment. A strategy was discussed on timing and logistics for selling and purchasing.

Trail Boss Report - Mike S. stated that we are grooming 4X a week and the trails are looking good especially after the bad weather recently. There is brushing, tree trimming and mowing that needs to be completed.

Fred J. was in attendance to continue the conversation regarding putting up three-sided shelter – “Rudy’s Corner” on Trail 41. Al S. stated there is a Forestry meeting this coming Monday and they will need a drawing, dimensions and a plan from our club for basic maintenance. Funding is coming from outside the club and Fred J. agreed that he, as a member of the club and with other volunteers, will be responsible for upkeep, monitoring and maintenance of the shelter. A motion was made by Mike P. / J.P., for the club to move forward with the project and our role in it. Motion passed.

Mike mentioned that the gate at the Cranberry Creek bridge still needs to be installed.

County Rep / NW Trails Report – Al S. was able to attend this meeting. Trail map invoicing is being completed and sent out. There is no other new information to present.

Membership Report – Betti W. presented her membership report. 25 Commercial memberships and 132 family memberships for a total of 157. Our numbers are down from 213 of last year.
